

# खासगी रुग्णालयांना महापालिकेचा दणका

मुंबई, दि. २(प्रतिनिधी): कोरोनावर नेमणूक केली आहे. खासगी रुग्णालयांबाबत दोन उपचार करताना खासगी रुग्णालयांनी भरमसाट बिल आकारणी करत रुग्णांच्या नातेवाईकांकडून घेतलेले तीन कोटी रुपये महापालिकेने परत करायला लावले आहेत. त्यामुळे अशा पद्धतीने जादा बिल आकारणी केलेल्या खासगी रुग्णालय व्यवस्थापनाचे धाबे दणाणले आहेत, तर रुग्णांच्या नातेवाईकांना दिलासा मिळाला आहे.

खासगी रुग्णालयात जादा बिल आकारले जात असल्याच्या तक्रारींची दखल घेत पालिका आरोग्य विभागाने कारवाईचा बडगा उगारला. आतापर्यंत एकूण दोन हजार तक्रारी आल्या. त्यापैकी १८५ तक्रारी जादा बिल आकारल्याच्या होत्या. त्या तक्रारींचा निपटारा करण्यासाठी महानगरपालिका प्रशासनाने विविध खासगी रुग्णालयांसाठी महानगरपालिका मुख्य लेखापरीक्षक खात्यातील लेखापरीक्षकांची नेमणूक केली आहे.

हजार तक्रारी पालिकेकडे प्राप्त झाल्या. यामध्ये १८५ तक्रारी या रुग्णांच्या नातेवाईकांकडून जादा पैसे आकारल्याच्या होत्या. तक्रारींची शहानिशा करत खासगी रुग्णालयांवर कारवाई करण्यात आली. या कारवाईत आकारलेले बिलाचे पैसे कमी करण्यात आले, तर काही तक्रारींचे निवारण करत रुग्ण किंवा रुग्णांच्या नातेवाईकांना पैसे परत करण्यात आले. पैसे परत केलेली रक्कम ही ३ कोटी, ३० लाख रुपये असल्याचे पालिका अतिरिक्त आयुक्त सुरेश काकाणी यांनी सांगितले. राज्य शासनाच्या निर्देशांनुसार खासगी रुग्णालयातील ८० टक्के खाटा महानगरपालिकेने ताब्यात घेतल्या. या ८० टक्के खाटांवर उपचार घेणाऱ्या रुग्णांकडून कोणत्या दराने शुल्क आकारणी केली पाहिजे, याबाबत राज्य शासनाने ३० एप्रिल रोजी आदेश काढला. या आदेशात आणखी सुधारणा करून सुधारित आदेश २१ मे २०२० रोजी जारी करण्यात आले. या आदेशान्वये निर्धारित केलेल्या दरानुसार संबंधित रुग्णालयांनी शूल्क आकारणी करणे गरजेचे आहे. असे असले तरी खासगी रुग्णालये अवाजवी आकारणी करीत असल्याच्या तक्रारी येऊ लागल्या. यासाठी महापालिकेच्या मुख्य लेखापरीक्षक खात्यातील प्रत्येकी दोन अधिकाऱ्यांची नियुक्ती केली आहे. या नियुक्तीमुळे बिल आकारणी बाबतच्या तक्रारींचे लवकर निवारण होत असल्याचे ते म्हणाले.

कोरोनाच्या 'आरटी-पीसीआर' चाचणीसह अर्धा तासात निदान होणाऱ्या 'ॲन्टिजेन' चाचण्यांची संख्याही वाढवली गेली आहे. सुरुवातीला एक लाख 'ॲन्टिजेन टेस्ट' वाढवल्यानंतर आता पुन्हा ५० हजार 'ॲन्टिजेन टेस्ट किट' मागवण्यात आल्या

आहेत. त्यामुळे कोरोनाचे निदान झटपट

या उमेदवारांना सांगण्यात आले. वरील सर्व उमेदवार शाळेत असताना इंग्रजी माध्यमाच्या शाळा खुप कमी प्रमाणात व गावापासून खूप दरवरच्या अंतरावर असल्याकारणाने या सर्वांनी शालेय शिक्षण मराठी भाषेतून घेतले. पण, महाविद्यालयीन शिक्षण पूर्ण इंग्रजी माध्यमात केलेले आहे. वरील सर्व गोष्टींचा विचार करून नियुक्ती मिळवून देण्यास सहकार्य करावे, असे आवाहन नोकरीपासून वंचित राहावे लागलेल्या शिक्षकांनी केले

दरम्यान, या शिक्षकांनी शिक्षण राज्यमंत्री बच्च कडू यांनाही पत्र दिले असून ९ ऑगस्ट, २०१९ रोजी दडवलेल्या शिक्षकांची पुन्हा भरती करण्याबाबत आग्रहाची विनंती केली आहे. दहावीपर्यंत मराठी माध्यमातून शिक्षण घेतलेल्याना भरती करून घेण्यास नकार दिला खरा, पण तो लेखी स्वरूपात दिला नाही. सुशिक्षित शिक्षकांना अशी लाजिरवाणी वागणूक देऊन का डावलले, याचा जाब म्हणून तुम्ही अपात्र आहात,' असे कारण विचारण्याची मागणी त्यांनी केली आहे.

दोष उमेदवारांचा; महापालिकेचा नाही शिक्षण सेवकांच्या दोन श्रेणी आहेत. एक 'एमपीएस' (मुंबई पब्लिक स्कूल) साठी आहे. त्यासाठी पाहिलीपासून उच्च शिक्षणापर्यंत इंग्रजी माध्यमाची अर्हता आहे. दुसरी 'युपीएस' (अप्पर पब्लिक स्कू) साठी आहे. यामध्ये दहावीपर्यंत मराठीसह कोणत्याही भाषेत शिक्षण चालते किंवा डीएड किंवा दहावी तत्समपैकी एकमध्ये इंग्रजी अशी अर्हता आहे. 'युपीएस'साठी मराठी माध्यमाचे उमेदवार घेतले. मात्र, 'एमपीएस'चा पर्याय निवडताना उमेदवारांनी काळजी घेतली नाही.
